MESSAGE FROM THE PRESIDENT

Dear Certified Psychodramatists:

Greetings to you all, and congratulations to the candidates who recently took the written certification examination — fourteen CP and six TEP candidates, with seven from the U.S., eight from Taiwan, three from China, and two from Canada. Congratulations on your hard work and dedication. Special thanks to

our multi-talented, multi-tasking Board Executive Director, Dale Richard Buchanan, for coordinating the administration of the test across multiple time-zones.

Fall is typically a busy time for the Board, this year was no exception. During our September meeting, we welcomed new Director, Michael Gross, CP representative, and returning Director Martica Bacallao, TEP representative. A major agenda item of the meeting was to prepare the 2017 written examination. Our goal was to write clear, coherent questions to enable candidates to demonstrate their knowledge and understanding. The exams are now being reviewed by members of our community who have offered their time and expertise for this task.

The Board addressed several other issues at our meeting. We have nearly finalized a process for new hires, including expedited hires in an emergency and routine hires. To ensure an equitable process, we developed structured questionnaires and scoring sheets for the interviews. The Board also continues to develop new organizational policies necessitated by the change of the Executive Director's position from contractor to employee.

The Board has given careful consideration to the Primary Trainer role, integrating feedback received at last year's Conversation Hour at the Annual ASGPP Conference. The concern is for the Primary Trainer to have sufficient time to observe and mentor the Trainee over time. Currently, the certification standards do not stipulate a specific number or percentage of training hours to be received with the Primary Trainer. However, the document, "The CP Journey" posted on the ABE website, does state that "a trainee must have a Primary Trainer who has provided a minimum of 390 hours of training ..." The point is to ensure

Rather than propose a change to the certification standards, the Board decided to undertake an educational effort. As a first step, the article, "Suggested Best Practice Guidelines for Primary Trainers," was published in the May 2017 *Board News*. The Board also discussed the possibility of a workshop on this topic targeted to both new and veteran TEPs.

In consideration of the challenging economic times, the Board decided, for the fifth consecutive year, not to raise the membership fees. Board policy states that certification is terminated for members who fail to renew. So, please protect your investment by ensuring you don't let your certification lapse.


